RESULTS OF THE COMMUNITY FACILITIES SURVEY – 2023

The area that our survey covered was a radius of 2 miles from Whitminster Village Hall. This was to allow users current and past to have their input. We also put this survey out to our current regular users and the users of the Pavilion via a digital copy to be passed on to their supporters and opposition users. Out of 2424 leaflet questionnaires that went out and an online survey completed we had a total of 105 responses. That equates to 0.04% returned.


However, the responses that where returned showed an overall support for the Management Committees ideas for the future of the Village Hall, Playing Field and Pavilion.

As we emerge from the pandemic and life is returning to near normal, do you think it is important that communities have a sporting space that they ca...me together to participate in sporting activities?




1. How often do you use the Village Hall


3. If you don't use the Hall, please can you tell us why? 13 responses




- It needs to become more energy efficient with future proofing for future trustees as well as users, current, and future.




1. How often do you use the Playing Field?




If you selected No to the above question please give reason below. 14 responses



1) How often did you use the old Pavilion 55 responses




2. If you did use the Pavilion, for what purpose 13 responses






4. Do you think that taking part in sports and activities at a new inclusive, multi-purpose Pavilion would make you feel m ore positive about life?


5. In your opinion would taking part in sporting activities at a modern, local sports and multi-use pavilion would relieve anxiety, improve mental health and physical health?







2. Do you think that the cleaning of the facilities should be done by a volunteer? 53 responses






4. If we employ a Caretaker do you agree that we should apply for grant funding to cover the costs or raise our hire charges accordingly?




Your age 55 responses



Do you have any mobility problems or are you registered disabled 51 responses




Would you consider supporting the Whitminster Village Hall & Playing Field Charity? 45 responses



If Yes to the above, how would you like to help?




Your Gender

Conclusion

THE VILLAGE HALL

It is very apparent that the community value the Village Hall, but are finding it increasingly expensive to use which we do understand. This is down to the economic pressures of today and we are striving to find ways to bring down costs and maintain the standards that we deliver. We have already started to replace the old wooden doors by replacing the Emergency Exit doors on the side of the hall. More funding shall be applied for to replace the other external doors and we are working to replace the lighting with LED through-out. The biggest and most costly job is for us to install solar/photovoltaic panels on the roof. There was not as much support for the installation of Electric Car Charging Points which will not be a priority and certainly will not go toward making the hall less expensive to run.

We also have a problem with Bouncy Castle insurance and it is a problem all around the country. Many village halls are still unaware of the problem. If any claim comes from an accident that results in a multi-million-pound payout then this will fall to the Trustees personally as these claims are too much for insurance companies to payout and keep the premiums affordable for village halls. We do not like having to tell our clients that they can't have a bouncy castle in but we cannot personally accept the liability should there be an accident. And we know we are loosing bookings from it but sadly these are the times we live in.

85% out of the 54 responses suggests that most people are satisfied with the hall.

THE PLAYING FIELD

Almost 50% of the 55 responses use the Playing Field don't use the playing field. But almost 25% do at least once a week and for a variety of reasons. We don't have dog shows on the playing field as someone suggested as dogs are not allowed on the playing field but we have had them at the village hall.

81% of the 42 responses are satisfied with the Playing Field. Some comments have noted the need to replace the Pavilion

THE PAVILION

74.5% of the responses on using the pavilion used it monthly. Interestingly more use it to watch Cricket than football. That is likely down to the weather and the fact that the old pavilion is cold and damp (even with the heating on in winter).

Out of 50 responses 98% agree that a good sports facility is important to improve and maintain health and fitness and out of 52 responses 63% strongly agree that being able to access a local sports and multi-use facility is important to help improve mental health and physical health.

These responses strongly suggest that if the Pavilion is replaced it will be used far more during the winter than it has been over recent years.

Suggestions also show that there is plenty of possible other uses with other various activities should the current user sports clubs not be able to utilize its availability all the time.

MANAGEMENT OF THE FACILITIES

For the most out of 53 responses, the community agree that the day to day maintenance is carried out by volunteers.

However out of 53 responses 43% neither disagree or agree where as 36% disagree that the Cleaning is done by volunteers. But interestingly out of 47 responses 55% agree that the charity employs a Caretaker and that 68% out of 52% agree that we should apply for grant funding to fund a caretaker.
